Financial Accounting Standards Board (FASB) ASU 2011-09 Required Disclosure about an Employer's Participation in a Multiemployer Plan

In September 2011, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update No. 2011-09, which revised the accounting disclosure requirements for employers participating in multiemployer pension plans. These new disclosure requirements are effective for public entities with annual reporting periods ending after December 15, 2011 and for nonpublic entities with annual reporting periods ending after December 15, 2012. The purpose of this page is to assist employers contributing to the Building Service 32BJ Pension Fund (the "Fund") by providing certain information about the Fund that may be necessary for employers to comply with the new FASB reporting requirements. Please note that the Fund has provided this information as a courtesy to contributing employers. The Fund is not, however, providing tax or accounting advice. In addition, the information below represents only a portion of the information required in accounting disclosures. Employers are encouraged to contact their tax and financial advisors regarding the scope, effective date and content of the reporting obligation as it applies to them.
