Financial Accounting Standards Board (FASB) ASU 2011-09 Required Disclosures about an Employer's Participation in a Multiemployer Plan

In September 2011, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update No. 2011-09, which revised the accounting disclosure requirements for employers participating in multiemployer pension plans. The purpose of this page is to assist employers contributing to the Massachusetts Service Employees' Pension Fund (the "Fund") by providing certain information about the Fund that may be necessary for employers to comply with the new FASB reporting requirements. Please note that the Fund has provided this information as a courtesy to contributing employers. The Fund is not, however, providing tax or accounting advice.
